However, what I found over and over again is that through my honesty and openness, I am subject to extortion attempts and character assassinations on a daily basis after "serving my time". This rat's nest of ignorance blossomed with the proliferation of the internet, and the areas of which individuals can quickly publish

false information for personal gain. The more successful you are the more you are a target for such criminals. I have 3 great examples of how I am subject to “fake news” extortion, libel, slander, and the list goes on and on - Daily.

An extraordinary record of compliance and success.

So, what do these extortionists do? Well, they write sensational articles, filled mostly with absolute lies about our company and me with really good search engine results. They use our key words and fake reviews to attract readers away from us on on to their fake platforms to steal money from our possible clients who are looking for us or for me. They have even attacked my name and

exploited online traffic from my children's books that are published by the largest educational publishing houses in the world. They have actually said I am not an author, even though my books are easily found online. They attack and tell lies about my education, even though when anyone can find my doctoral dissertation on ProQuest, which is the academic platform for published academic works. The amount of sectors of my life they have attacked would drive most to suicide. And I clearly understand how targets of internet bullies and revenge posters drive kids to kill themselves. The pressures on me and my family could have been exhausting. But I sleep at night because I know the perpetrators are recognised by reasonable people and their rawlings are identifiable and they have no real credibility, because they are thieves and they know it. We just need to redefine their false shield and establish harsh penalties against them.

There are companies out there that scrape the Internet for certain negative key words of sensationalism. When they find the key words, their AI and staff rewrite the articles and perpetuate the lies, steal more traffic and mislead readers down very dangerous rabbit holes. But this isn't the old Arizona with real men; you can't be a real man and do that anymore. The fake keyboard warriors just laugh in your face, know ing you have no real recourse. Hmmm, Oh, bring a law suit, you say --- no. The real criminal work around that two after you have spent years and hundred s of thousands of dollars. They find ways to stay in the cracks.
